## **VENDOR AGREEMENT, WAIVER AND RELEASE**

Vendors agree by signing, to accept the following hold harmless clause acknowledging that they have received and read a copy of the Application and Rules and Regulations and agree to abide by the guidelines and decisions made by the Rio Linda Elverta Recreation and Park District (RLERPD) and the Recreation Supervisor. I have carefully read the description of EVENT(S) for which I/we are registering and in consideration for being permitted by the RLERPD to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity. This release is intended to discharge in advance to RLERPD, its officers, officials, employees, and volunteers from any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above: It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is binding to my heirs and assigns. I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage, cost, or experience, which they may incur as the result of my death or injury, or property damage that said minor may sustain while participating in said activity. Furthermore, the undersigned allows any photos taken of vendor or vendor's staff or family members during participation of any district events or programs to be used in any future promotional materials produced by the district. The parties hereto mutually agree as follows: The Vendor is an independent contractor in all respects in the performance of this Agreement and shall not be considered an employee of the District for any purpose. No employee benefits shall be available to Vendor or employees of vendor in connection with the performance of this Agreement. Except as provided in the Agreement, District shall not pay salaries, wages, or other compensation to vendor for performing services hereunder for District. District shall not be liable for compensation or indemnification to vendor for injury or sickness arising out of performing services hereunder. Vendor attests that services provided comply with all applicable Federal, State and Local regulations. This Agreement and any documents or instrument attached hereto or referred to herein integrate all terms and conditions mentioned herein or incidental hereto supersede all negotiations and prior writing in respect to the subject matter hereof. In the event of conflict between the terms, conditions, or provisions of this Agreement and any such document or instrument, the terms and conditions of this Agreement shall prevail.

I HAVE CAREFULLY READ THIS AGREEMENT, WAIVER, AND RELEASE FORM AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN ME AND THE RIO LINDA ELVERTA RECREATION and PARK DISTRICT AND I SIGN OF MY OWN FREE WILL. \*Occasional Seller is defined as a non-taxable sale; generally, seller does not make sales more than 2 times per 12 month period.
