School Districts - Qualifications: Any person, regardless of sex, who is 18 years of age or older, a citizen of the state, a resident of the school district, a registered voter, and who is not disqualified by the Constitution or laws of the state from holding a civil office, is eligible to be elected or appointed a member of a governing board of a school district without further qualifications. An employee of a school district may not be sworn into office as an elected or appointed member of that school district's governing board unless and until he or she resigns as an employee. If the employee does not resign, the employment will automatically terminate upon being sworn into office. Education Code 35107

NOTICE IS FURTHER GIVEN that the hours for filing all nomination documents will be Monday through Friday, 8:00 a.m. to 5:00 p.m., excluding holidays.

NOTICE IS FURTHER GIVEN that individuals wishing to download the Candidate's Guide may do so on our website at www.elections.saccounty.net.

NOTICE IS FURTHER GIVEN that candidate filing begins on Monday, July 18, 2016 and ends on Friday, August 12, 2016, to file the Declaration of Candidacy and Candidate Statement with the Registrar of Voters office. If an incumbent who is eligible to file for re-election fails to file their Declaration of Candidacy by August 12, 2016, there is a 5-calendar day extension allowed for any qualified person other than the incumbent to file for the office.

NOTICE IS FURTHER GIVEN that the 10-calendar day review period for Candidate Statements submitted by August 12, 2016 (E-88) will begin on August 13, 2016 and conclude on August 22, 2016. During this 10-calendar day review period, any person may seek a writ of mandate or injunction requiring any or all of the material in the candidate statement to be amended or deleted. All writs of mandate must be filed no later than the end of the 10-calendar day public examination period. (EC 13313)

NOTICE IS FURTHER GIVEN that the 10-calendar day review period for Candidate Statements for offices in extension submitted by August 17, 2016 will begin on August 18, 2016 and conclude August 27, 2016. During this 10-calendar day review period, any person may seek a writ of mandate or injunction for any of the material in review to be amended or deleted. All writs of mandate must be filed no later than the end of the 10-calendar day public examination period. (EC 13313)

NOTICE IS FURTHER GIVEN that in the event there are no nominees or insufficient nominees for the office and a petition for an election is not filed with the Registrar of Voters within the time period prescribed by Election Code 10515, an election will not be held, and an appointment will be made by the supervising authority.

NOTICE IS FURTHER GIVEN that for measures submitted by the August 1, 2016 recommended due date, all arguments in favor of and against shall be submitted to the Sacramento County Elections Office by August 11, 2016. The arguments shall not exceed 300 words in length and may be withdrawn, but not changed, prior to and including August 11, 2016. The 10-calendar day review period for said arguments will begin on August 12, 2016 and conclude on August 21, 2016. Measure materials to be printed in each sample ballot and information pamphlet. Rebuttals to said arguments in favor of or against must be received by August 15, 2016, shall not exceed 250 words in length and may be withdrawn, but not changed, prior to and including August 15, 2016. The 10-calendar day review period rebuttals will begin on August 16, 2016 and conclude on August 25, 2016.

NOTICE IS FURTHER GIVEN that for measures submitted by August 12, 2016, arguments in favor of and against shall be submitted to the Sacramento County Elections Office by August 16, 2016, shall not exceed 300 words in length and may be withdrawn, but not changed, prior to and including August 16, 2016. The 10-calendar day review period for said arguments will begin on August 17, 2016 and conclude on August 26, 2016. Measure materials to be printed in each sample ballot and information pamphlet. Rebuttals to arguments in favor of and against must be received by August 18, 2016, shall not exceed 250 words in length and may be withdrawn, but not changed, prior to and including August 18, 2016. The 10-calendar day review period for any rebuttal arguments filed by August 18, 2016 will begin on August 19, 2016 and conclude on August 28, 2016. During this 10-calendar day review period, any person may seek a writ of mandate or injunction for any of the material in review to be amended or deleted. All writs of mandate must be filed no later than the end of the 10-calendar day public examination period.

NOTICE IS FURTHER GIVEN that Vote-by-Mail processing may begin on the tenth business day before the election, which is Tuesday, October 25, 2016. Persons interested in viewing this procedure should contact Karen Startup of Voter Registration and Elections at (916) 875-6276 for further information. All ballots cast at the November 8, 2016 Presidential General Elections shall be tallied at a central counting place, the Voter Registration and Elections Office at 7000 65th Street Suite A, Sacramento, California, beginning at 8:00 p.m. election night and continuing until the count is completed.
