

MEMORANDUM OF UNDERSTANDING


Rio Linda Elverta Foundation For The Future and Rio Linda Elverta Recreation and Park District

The Following is a Memorandum of Understanding ("MOU") between the RLE Foundation For The Future ("THE FOUNDATION") and the Rio Linda-Elverta Recreation and Park District ("THE DISTRICT") as related to the collaboration of the two agencies in future endeavors.

1. The FOUNDATION was formed to assist THE DISTRICT carry out its objective of providing recreation and park services to its citizens.
2. The FOUNDATION will endeavor to obtain grants, corporate and private donations, and conduct fundraising events that will be used to enhance the DISTRICT'S recreational programs and the DISTRICT'S parks and recreational facilities.
3. THE FOUNDATION will provide financial assistance to the DISTRICT (through donations or the direct purchases of items which will then be contributed to the DISTRICT).
4. THE FOUNDATION will provide other equipment to the DISTRICT such as computers for youth and teen programs and playground equipment.
5. THE FOUNDATION will provide scholarships through the DISTRICT, to be used for educational purposes to an accredited educational institution and awarded to students of all ages.
6. THE FOUNDATION will hold quarterly meetings throughout the year. One of these meeting must take place in the month of June after the FOUNDATION has submitted annual returns to both the Internal Revenue Service and the California State Franchise Tax Board.
7. THE DISTRICT will provide the use of facilities, including the Rio Linda Elverta Community Center, and the Depot Facility to the FOUNDATION free of charge or at a minimal fee for fundraising events.
8. THE DISTRICT shall provide general liability as well as directors, officers, and employees liability insurance, SAM and Worker's Compensation coverage to the FOUNDATION for facility usage and programs in the following amounts: \$2,000,000/\$4,000,000 for general liability; \$1,000,000 each for Worker's Compensation and SAM.
9. THE DISTRICT agrees the publicize FOUNDATION fundraisers and other FOUNDATION events through the DISTRICT'S Activity Guide and other publications that the DISTRICT may distribute throughout the year.
10. THE DISTRICT agrees to collaborate with the FOUNDATION on selected special events to commence throughout the year.

This agreement is in effective through December 31, 2026. This MOU will remain in effect beyond December 31, 2026 on an annual basis if neither THE FOUNDATION nor THE DISTRICT renews the agreement.
